The employees/officers who are on leave/LTC/TD have to make their own arrangement to takeover the accn during their absent. Such individuals /officers have to apply fresh after lapse of one year.
- 5. The vacant quarters are allotted as per the date of vacation and the seniority of the employees. Change of accn will not be considered without taking over the accn allotted. No request for alternate accn will be considered. Please note that if the accn is not taken over by 18 Aug 2025 the allotment automatically stands cancelled.
